### a. Transport from Nice Airport to the Principality of Monaco

#### **Air transport**

The Nice-Côte d'Azur Airport is connected to 86 destinations – The Airport is connected to the main European "HUBS".

### b. Means of transportation for participants

The Principality of Monaco is accessible from Nice Côte d'Azur Airport by several means of transportation:

#### **Bus Transfer**

**Transfer by bus** are carried out by the shuttle called « **110 - XPRESS Monaco/ Menton** ».

#### **Departures from Nice International Airport Terminal 1 & 2**

- Daily from 08.30 am to 10.00 pm.
- Every half an hour.
- The line provides services to the Monaco hotels

#### **Departures from Monaco to Nice International Airport Terminal 1 & 2**

From 06.40 am to 07.45 pm

**Bus stop is the "Monte-Carlo Place d'Armes" (please have a look at the schedule) however, you could ask the bus driver if he will stop in Fontvieille next to the Marriott.**

Itinerary from the Bus stop to the Marriott Hotel can be find below.

If you stop at Place d'Armes and you don't feel like walking, you can take the n°6 bus (price is 2€, sale tickets onboard) and it will stop across the road from the Marriott Hotel in Fontvieille (you can ask the bus driver where to stop).

## OTHER INFORMATION

Participants must ensure their own medical and other insurance covers for the duration of the meeting.

## **VISA**

Entry to the Monaco Territory is through the French Territory. The entry and stay of participants on the Monegasque territory will be allowed for holders of valid travel documents (including stamps, visas and authorizations allowing the entry and stay on the French territory).

**Visa demands should be done at the French Consulate or Embassy in the participant's country or in any other country signatory of the Schengen Agreement.**

**The official invitation letter will be necessary for the visa demand.**

For short stays (less than 90 days), European regulations specify the list of countries whose nationals are exempt from visa requirement to enter the Schengen Area.

Exempt from visa requirement for France's territory in Europe are :

- citizens of the EU, [the EEA](#) and Switzerland ;
- nationals of the following countries, whatever the reason for their stay: Albania \*, Andorra, Antigua and Barbuda, Argentina, Bahamas, Barbados, Bosnia and Herzegovina \*, Brunei Darussalam, Canada, Chile, Costa Rica, Croatia, El Salvador, Guatemala, Honduras, Israel, Malaysia, Mauritius, Monaco, Nicaragua , New Zealand, Panama, Paraguay, Saint Kitts and Nevis, San Marino, Holy See, Seychelles, Taiwan (passport bearing identity card number), Uruguay, Montenegro\*, FYROM\* and Serbia\* ;  
*(\*bearers of biometric passports only)*
- nationals of the following countries: Australia, Brazil, USA, Japan, Mexico, Singapore, South Korea Venezuela. If you are gainfully employed, the exemption only applies if you can produce a work permit ;
- holders of a valid residence permit for France ;
- holders of a residence permit issued by a state applying the Schengen Agreements ;
- holders of certain travel documents issued by an EU Member State ;
- holders of a British National (Overseas) passport.

If you have a valid Schengen visa, you can enter and stay in the Principality of Monaco for 90 days maximum.

We recommend that you check the paperwork you have to fill out (including vaccination certificates and insurance) with the Embassy or French Consulate in your country.
