

REPORT ON INCOMES AND EXPENDITURES RELEVANT TO THE TRUST FUND AND EXTERNAL CONTRIBUTIONS FOR 2020-2022¹

GENERAL COMMENTS

The 2020-2022 budget was adopted by the Seventh Meeting of the Parties to ACCOBAMS (Istanbul, Türkiye, 5-8 November 2019) under Resolution 7.6.

The funds available for implementation of the Agreement consist of:

- 1) the Trust Fund, accrued through Parties' Ordinary Contributions,
- 2) External Funds, Voluntary Contributions granted by Parties, or co-funding through other entities for activities linked to priority conservation issues; and

This report presents an overview of incomes and expenditures in relation to the Trust Fund for 2020-2022, as of 30th June 2022. The income sources presented comprise the adopted budget for 2020-2022, which is based on Ordinary Contributions from Parties, and Voluntary Contributions kindly provided by Parties, as well as co-fundings provided by entities that jointly developed activities with ACCOBAMS in relation to conservation priorities.

A breakdown of expenditures is shown in table 3. "Adopted budget - Ordinary Contributions - and expenditure as of 30 June 2022", alongside with the adopted budget for 2020-2022, and the budget accrued by remaining amounts from previous years.

Information on expenditures related to the Supplementary Conservation Fund is provided in document ACCOBAMS-MOP8/2022/Doc17.

The Secretariat is grateful for the support received from Governments, governmental and non-governmental Organizations and other Institutions towards the implementation of the Agreement. Special acknowledgments are due to the Principality of Monaco for their in cash and in-kind contributions and to the Italian, Spanish and Maltese Governments for their significant Voluntary Contributions provided during the triennium 2020-2022.

I. ORDINARY CONTRIBUTIONS TO THE TRUST FUND

During the 3-years period 2020-2022, 24 countries were Parties to the Agreement.

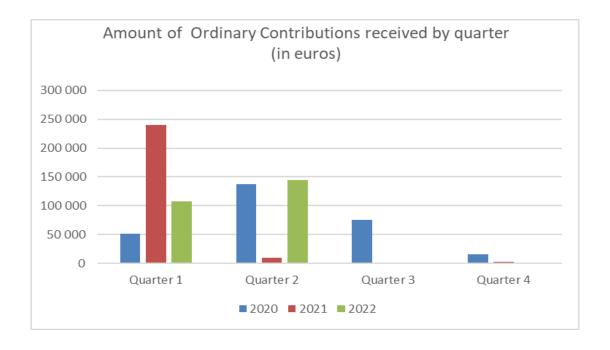

In accordance with Appendix 1 — "Financial arrangements between the Government of H.S.H the Prince of Monaco and the Permanent Secretariat of ACCOBAMS" of ACCOBAMS Resolution 6.2 on the Headquarters Agreement with the Host Country, the Principality of Monaco provides both in-cash and in-kind contributions to support the functioning of the ACCOBAMS Secretariat.

The financial support perceived by Monaco in the framework of the Headquarters Agreement feeds in a different ACCOBAMS bank account and remains outside the scope of the Trust Fund, as it relates to the Headquarters Agreement with regard to the regular functioning of the Secretariat including staff costs.

The Headquarters Agreement budget for the triennium is convened between the Principality of Monaco and the Executive Secretary and is subjected to the verification of, and validation by, the Fund management Controller.

The in-cash contribution provided by the Principality of Monaco is aimed at enabling the general functioning of the Secretariat whose premises are located in the Principality, and at funding the salaries of both the Executive Secretary and the Assistant to the Executive Secretary.

The in-kind contribution provided by the Principality of Monaco is aimed at hosting the Secretariat in Monaco and at hosting two Programme & Project Officers working at the Secretariat.

For information purposes the support provided by the Host Country is shown in table 9 below.

Annex 1 Explanatory note on Trust Fund Budgetary lines

1. Administration and general management

Budget Line 1101: Executive Secretary housing allowance

The remuneration of the Executive Secretary is composed of the salary provided by the Host Country and a complementary allowance from the Trust Fund covered by this Budget Line.

Budget Lines 1102 & 1103 & 1104: Programme & Project Officers and Accountant

These budget lines were used to cover expenditure related to the ACCOBAMS Secretariat positions of Programme & Project Officers, notably salaries and social contributions. Miscalculated wages in 2019 are at the origin of this insufficiency, which was solved through remaining amounts in the same budget section, and thanks to a unpaid 18 weeks maternity leave of one Programme & Project Officer.

Budget Line 1201: Translators

The working languages of ACCOBAMS meetings are English and French. This budget will enable the translation of documents for the 8th Meeting of the Parties.

Budget Line 1202: Fund management controller

According to Resolution 7.6 adopted by the Parties, the budget is audited each year by a Fund management controller. This budget line covers the fees of the Fund management controller during the Triennium

Budget Line 1203: External assistance

During the 2020-2022 triennium, the amounts allocated to this budget line were mainly assigned to services provided by legal advisors.

Budget Line 1300: Bank fees

Bank charges have considerably decreased following the adoption of e-banking service (free of bank charges).

Budget Line 1400 Hospitality

The over expenditure with hospitality costs was linked to few improvements at the Secretariat and correspondence.

Budget Line 1501: Sub Regional Coordination unit

This line is intended to assist the Sub Regional Coordination Units to develop activities related to ACCOBAMS objectives in the two sub-regions, and attendance at ACCOBAMS meetings.

The expenses related to the activities with the Sub Regional Coordination Units covered:

- the participation of representatives of the two Sub Regional Coordination Units (Black Sea Commission Permanent Secretariat and UNEP/MAP-SPA/RAC) to the Thirteen and Fourteenth Meetings of the ACCOBAMS Scientific Committee and to the Fifth Meeting of the Extended Bureau.
- the participation of Mediterranean and Black Sea experts during the IUCN World Congress in September 2021 (Marseilles, France) and during the MPAs Forum in December 2021 (Monaco)
- the support of the organization of the 33rd annual European Cetacean Society conference

Budget Line 1502: Secretariat staff travels

During the Triennium 2020-2022, the Secretariat attended meetings and workshops to (1) liaise with other Organizations and strengthen collaborations to implement the work programme and (2) to establish and maintain close contacts with Parties and other Riparian countries to assist them in work programme implementation.

During these meetings, the Secretariat presented the activities and the Agreement, distributed information material, investigated potential for joint activities and co-funding possibilities, worked with the competent authorities on the various means necessary to enhance ACCOBAMS implementation at a national level.

Moreover, in order to better promote the Agreement, the Secretariat recruited an international Consultant to develop an ACCOBAMS Communication Strategy proposal in view of its adoption at the Eighth Meeting of the Parties. During

the 25th anniversary of ACCOBAMS, they produced a short promoting video reflecting the ACCOBAMS scope of work and main achievements

Furthermore, during the COVID crisis, since most of the meetings were online, the Secretariat has subscribed to Zoom.

2. Institutional Meetings

Budget Line 210: Meeting of the Parties

The budget adopted for this budget line was intended to support Parties in need of financial assistance and experts to attend the Eighth Meeting of the Parties (28^{th} November – 2^{nd} December 2022, Malta)), to prepare working documents and to contribute to the organization of MOP7.

Budget Line 220: Scientific Committee

Two Scientific Committee Meetings were held during this triennium:

- The 13th Meeting of the Scientific Committee was organized on 26th-28th February 2020 in Cap d'Ail, France.
- The 14th Meeting of the Scientific Committee was organized on 22nd-26th November 2021 in Monaco.

The savings made during these two meetings by the Secretariat enabled support provided to the Chair of the Scientific Committee to attend relevant Meetings.

Budget Line 2300: Bureau

The expenses of this budget line covered the organisation of three Meetings of the Bureau during the triennium 2020-2022

- The extraordinary Bureau Meeting met as Recruitment Committee for the selection procedure of the Executive Secretary position, in February 2020.
- The Thirteenth Bureau Meeting was organized on 9-11 December 2020, online;
- The Fourteenth Bureau Meeting was organized on 18-19 January 2022, online;
- The Fifth Meeting of the Extended Bureau was organized on 26-27 April 2022 in Monaco.

In order to ensure the good running of the Meeting, the Secretariat acquired a videoconferencing equipment

Budget Line 2400: Meeting of National Representatives (previously called Regional Workshops)

The Fifth Meeting of National Representatives was held 12 to 15 July 2021, online.

The respective budget line was used to update the Online National Report which will be used by Focal Points in 2022 prior to MOP8.

Budget Line 2500: Follow up Committee Meeting

The expenses of this budget line covered the organisation of the Third Meeting of the ACCOBAMS Follow up Committee which was organized online on $29^{th} - 30^{th}$ March 2022.

A simultaneous translation was proposed to facilitate the exchanges.

3. Conservation actions

Budget Line 51:

The budget available under this line was deleted in accordance with Resolution 7.6.

The unspent 2019 budget from this budget line was transferred to the secured fund.

Budget Line 52: Human-cetacean interactions / Emergency situations

The budget line was used to cover the following activities:

- promote of the implementation of the « High Quality Whale Watching * » certificate for operators
- support a study on the identification of the hot spots of whale watching activities in the ACCOBAMS Area and
 at testing the proposed common procedure to use whale watching vessels as platform of opportunity (with
 the Monaco voluntary contribution);

prepare a review of relevant legal provisions related to the use of drift nets in the ACCOBAMS Area; and get
information about existing legal instruments and measures conceived to nationally enforce the ACCOBAMS
provisions on the issue.

Budget Line 53: Habitat/ Research and monitoring

The budget available on this budget line was used to carry out activities related to Marine Protected Areas/Cetacean Critical Habitats (CCH) and to reinforce collaboration with the various international bodies, such as SAP/RAC, ASCOBANS, ECS, MedPAN, etc...., as follows:

- support the ongoing process on the assessment and reassessment of the IUCN conservation status of cetaceans in the ACCOBAMS Area;
- drafting ACCOBAMS Conservation Management Plans for 4 species, especially with the organization of a CMP drafting workshop on 7-9 March 2022, in Cap d'Ail, France
- assist expert in drafting a National Action Plan for Algeria; revise and promote ACCOBAMS Cetacean Critical Habitats.

Budget Line 54: Public awareness / Dissemination of information

The budget line was used to:

- Provide support the functioning of MEDACES for 2019, with the voluntary contribution of Spain for 2019;
- Host the ACCOBAMS website;
- Improve the existing MMO/PAM training and to initiate the development an online training;
- Celebrate the 25th ACCOBAMS Anniversary (25 years logo, short promoting video, anniversary ceremony...);

Create and disseminate communication material for public awareness and for distribution to meetings where ACCOBAMS was represented
