Note of the Secretariat:

In accordance with ACCOBAMS Resolution 8.3 "Scientific Committee", adopted during the Eighth Meeting of the Parties in December 2022, three members of the Scientific Committee should be experts proposed by IUCN, as stated in Article 2, paragraph 1 of the annexed Rules of Procedure.

In this context, and ahead of the Sixth Meeting of the ACCOBAMS Extended Bureau (23 - 24 April 2025, hybrid - Nice), the ACCOBAMS Secretariat invited IUCN to designate three experts for the Scientific Committee for the 2026–2028 period and to submit their *curricula vitae*.

The letter, which includes the proposed nominations, from Mr Maher Mahjoub, Director of the IUCN Cooperation Center for the Mediterranean, was received on 7 April 2025.

This letter was presented during the Sixth Meeting of the ACCOBAMS Extended Bureau.
