According to Article 14.2 of the Rules of Procedure of the Meeting of the Parties:

"Representatives of Parties which are three or more years behind in paying their subscriptions on the date of the opening session of the Meeting of the Parties shall not be eligible to vote. However, the Meeting of the Parties may allow such Parties to continue to exercise their right to vote if it is satisfied that the delay in payment arises from exceptional circumstances."

In November 2025, Countries which are more than three years behind in paying their ordinary contributions are Albania, Libya and Syria.

The Secretariat has received a formal letter from Libya explaining the "exceptional circumstances" originating the delay in payment. This letter is reflected below.

Subject: Explanation of Exceptional Circumstances Regarding Delay in Payment of **Ordinary Contributions**

Dear Executive Secretary,

In reference to Article 14.2 of the Rules of Procedure of the Meeting of the Parties (MOP), and to your communication requesting clarification regarding Libya's arrears in ordinary contributions, I would like to convey the following on behalf of the State of Libya.

The Government of Libya acknowledges the outstanding contributions due under ACCOBAMS and reaffirms its full commitment to meeting all obligations under the Agreement. The delay in payment over the past years has resulted from exceptional national circumstances beyond our control, including ongoing financial constraints, fluctuations in public budget allocations, and administrative delays associated with internal restructuring across governmental institutions.

Despite these challenges, the Government of Libya reiterates its strong support for ACCOBAMS and its objectives, and recognizes the importance of maintaining active participation, including the right to vote at the Ninth Meeting of the Parties (MOP9), to be held in Cyprus from 18 to 21 November 2025.

We also wish to inform the Secretariat that the Ministry of Environment, in coordination with the Ministry of Foreign Affairs and International Cooperation, has already initiated all necessary financial and administrative procedures to settle the outstanding contributions. Both ministries are actively working to ensure that the payment is processed as soon as possible, in accordance with national financial regulations.

In light of the above, and considering the exceptional circumstances outlined, the State of Libya respectfully requests that the Meeting of the Parties consider allowing our delegation to retain its voting rights during MOP9.

We remain fully consuitted to strengthening our cooperation within ACCOBAMS and to contributing effectively to the conservation of cetaceans in the Mediterranean and Black Seas.
