REPORTS OF THE LTMP CONTACT GROUP MEETINGS

Note of the Secretariat:

Through Resolution 8.10 on the ACCOBAMS Long-Term Monitoring Programme, Parties committed to facilitate the implementation of regular basin-wide synoptic surveys, by endorsing recommendation 14.1 of the Scientific Committee, in order to ensure systematic monitoring of the distribution and abundance of cetacean populations in the ACCOBAMS Area.

Under the Resolution, Parties were invited to:

- to **appoint a national contact person to participate in a LTMP Contact Group** to define implementation conditions and protocol for logistics (research platform, human means, equipment, training, etc.) and administration (survey restrictions, permits, etc.) related to undertaking basin-wide synoptic surveys based upon the experience gained from ASI-I, taking into account the guidance provided in Recommendation 14.1 of the Scientific Committee".

In this context, Parties were requested to officially appoint a national representative for the LTMP Contact Group prior to 31/12/2023. The composition of the LTMP Contact group as for October 2025 is annexed to this document (see Annex I: LTMP Contact Group Composition).

The LTMP Contact Group met five times between January 2024 and October 2025 to clarify and gather information on expected contributions from their countries (whether in cash or in kind), as required by Resolution 8.10.

The Meetings were all held online on the following dates:

- 29 January 2024
- 11 March 2024
- 18 June 2024
- 4 April 2025
- 1 October 2025

REPORT OF THE FIRST MEETING OF THE LTMP CONTACT GROUP ONLINE 29 JANUARY 2024

The First Meeting of the Long-Term Monitoring Programme (LTMP) Contact Group was held online on 29 January 2024. A total of 38 members from 17 countries participated in the meeting. The list of participants is <u>annexed</u> to this report.

The primary objective of this first meeting was to discuss the development of the second edition of the ACCOBAMS Survey Initiative (ASI-II) and to collect the most recent information on the ASI-II development at the national levels, gathering input from each participating country of the ACCOBAMS Long-term monitoring programme contact group.

I. CONCLUDING REMARKS

- 1. The importance of capitalizing and replicating the first ASI under the "synoptic" framework proposed in the ASI-II project proposal, which is to be aligned with a specific Protocol, methodology and previous trainings coordinated by a scientific coordinator was stressed;
- 2. It was highlighted that the overall draft timetable needs to be streamlined so to enable the launching of the basic administrative requirements (mobilizing a scientific coordinator and a coordination team) towards the implementation of the ASI-II operational part to be deployed in the Mediterranean in 2025 and in the Black Sea in 2026;
- 3. The importance of having timely access to sufficient information on the financial and in-kind resources provided by the Parties for the initial phase of ASI-II was stressed, particularly as this information is crucial for the Secretariat to effectively engage with potential external donors.
- 4. In conclusion, it was mentioned that a table mentioning possible in-kind contributions would be provided by the Secretariat for the countries to fill-in their envisaged national contributions.

REPORT OF THE SECOND MEETING OF THE LTMP CONTACT GROUP ONLINE 11 MARCH 2024 | 10:00 – 12:00 CET

The Second Meeting of the Long-Term Monitoring Programme (LTMP) Contact Group was held online on 11 March 2024. The primary objective of this meeting was to provide an update since the Second Meeting of the LTMP Contact Group held on 29 January 2024 on the state of play of the ongoing preparatory phase, which is expected to be finalised during the first half of 2024.

I. CONCLUDING REMARKS

- 1. It was stated that the preparatory work of the Contact Group is of vital importance so to have clarity about if and when the next stage can be started, specifically, the scientific preparation required to implement ASI-II, which is necessary to launch the operational campaign in 2025 in the Mediterranean and in 2026 in the Black Sea.
- 2. It was further highlighted that only when clarity on sufficient available funding—both internal and external—is achieved, will the scientific preparation of ASI-II be able to proceed, namely through the recruitment of a coordination team, including a scientific coordinator, as planned, which is expected to happen during the first half of 2024.
- 3. It was concluded that the Contact Group will not meet again unless substantial new information is provided.
- 4. It was also concluded that new information on voluntary contributions or in-kind support is requested from the Contact Persons prior to 27 May 2024.
- 5. Finally, it was stated that by early June 2024 the Secretariat should report to the Bureau on the state of play of ASI-II funding in face of the project planning.

The revised composition of the LTMP Contact Group is annexed to this report.

REPORT OF THE THIRD MEETING OF THE LTMP CONTACT GROUP ONLINE 18 JUNE 2024 | 10:00 – 12:00 CET

The Third Meeting of the Long-Term Monitoring Programme (LTMP) Contact Group was held online on 18 June 2024. A total of 21 members of the LTMP Contact Group from 17 countries participated in the meeting. The list of participants is <u>annexed</u> to the report.

The primary objective of this meeting was to provide an update on the progress made in the development of the second edition of the ACCOBAMS Survey Initiative (ASI-II) and to collect the most recent information on ASI-II development at the national levels, gathering input from each participating country of the ACCOBAMS Long-term monitoring programme contact group.

I. CONCLUDING REMARKS

- 1. It was stated that the LTMP Contact Group met three times in 2024 to gather information from countries on contributions, according to Resolution 8.10, which was necessary to have clarity on existing financial means. Such assessment was required by MOP8 as it is indispensable to determine the date of start and ending of the initiative, as well as for the launch phase of ASI-II, as reflected in the corresponding timeline.
- 2. It was further highlighted that the preparatory stage to launch ASI-II was expected to be concluded during the first half of 2024, to recruit a scientific team and to prepare the field work during the second half of 2024.
- 3. In face of the current situation, the discussions of the 3rd LTMP Contact Group Meeting held today (18th June 2024, online) resulted in main conclusions, which will be presented to the 16th Bureau meeting planned for this afternoon.

The first conclusion was to postpone the starting date of ASI-II to 2026, at this stage, to give time to:

- pursue the efforts of Countries and the Secretariat in seeking the necessary funding for launching the initiative.
- have the necessary funds to recruit the coordination personnel at the Secretariat and the Scientific coordinator, in accordance with point VI of the project (Project Governance): "full-time Project manager, full-time administrative assistant and the Scientific coordinator".
- use the momentum of the political context of the 2025 UNOC to increase visibility of ASI-II.
- 4. The second conclusion was that there is an urgent need to recruit a full-time ASI-II Project manager and a full-time administrative assistant in the Secretariat, as well as the Scientific Coordinator.
- 5. The third conclusion was that there is a need to consult the Scientific Committee and other relevant experts on the need to adapt the current ASI-II, including the survey design, bearing in mind new and environmentally friendly technologies and the need to reduce costs.

REPORT OF THE 4TH MEETING OF THE LONG-TERM MONITORING PROGRAMME CONTACT GROUP ONLINE – 4 APRIL 2025 | 10:00 – 12:00 CET

The Fourth Meeting of the Long-Term Monitoring Programme (LTMP) Contact Group was held online on **4 April 2025**, **from 10:00 to 12:00 CET.** A total of 21 members from 16 countries participated in the meeting. The list of participants is <u>annexed</u> to this report.

The primary objective of this meeting was to provide an update on the progress made in the development of the second edition of the ACCOBAMS Survey Initiative (ASI-II) and to collect the most recent information on the ASI-II development at the national levels, gathering input from each participating country of the ACCOBAMS Long-term monitoring programme contact group.

I. OPENING AND PRESENTATION OF PROGRESS

- 1. Mrs. Maylis Salivas, ACCOBAMS Executive Secretary, opened the meeting by welcoming participants and presenting the agenda. She then delivered a presentation summarizing the latest developments related to ASI-II since the last LTMP Contact Group meeting held in June 2024.) The presentation is <u>annexed</u> to this report.
- 2. She began by revisiting the background of ASI-II, referring to the 8th Meeting of the Parties (MoP8) and the endorsement of Resolution 8.10, "ACCOBAMS Long-Term Monitoring Programme." This resolution outlines the framework for the next synoptic, basin-wide survey to be organized as part of ASI-II.
- 3. Mrs. Salivas then highlighted the recent key developments, stemming from the conclusions of the last LTMP Contact Group meeting, as well as from the subsequent 16th and most recent 17th Bureau meetings.
- 4. She mentioned that the Secretariat has launched a consultancy call for an expert to provide advisory, technical, and administrative support for the development of ASI-II in 2025. Offer submitted by Ms. Julie Belmont (former ASI-I Project Officer) was selected.
- 5. Mrs Salivas then announced that a proposal was submitted by the Secretariat to organize a side event on ASI-II during the upcoming United Nations Ocean Conference (UNOC3) in the Blue Zone. This initiative has received strong support from 13 ACCOBAMS Parties and 14 partners, including CMS and IWC. The event aims to reaffirm countries' commitment and showcase tangible support for this key ACCOBAMS initiative.
- 6. She finally presented the Three-Phase Approach for 2025 as follows:
 - Phase 1 (March–June 2025): Preparation for the UNOC3 side event and initiation of ASI-II organizational activities.
 - Phase 2 (July-November 2025): Continued preparation for ASI-II, including the development of LTMP and ASI-II documentation for MoP9, along with intensified fundraising efforts.
 - o *Phase 3 (November–December 2025):* Subject to decisions made at MoP9, this phase will focus on scaling up preparations for the full-scale 2026 survey.

II. REMARKS FROM THE SCIENTIFIC COMMITTEE

- 7. Dr. Simone Panigada, Chair of the ACCOBAMS Scientific Committee (SC), addressed the participants, noting that 2025 will be a demanding year with tight schedules. He expressed the Committee's strong commitment to supporting ASI-II by providing scientific advice and guidance, coordinated by Mr. Tilen Genov, Task Manager for the Working Group on Cetacean Population Estimates and Distribution.
- 8. Dr. Simone Panigada emphasized that one of the most important actions of the next triennium is the continuation of ASI. He recalled the significant outputs published in *Frontiers*, derived from ASI I, which have been downloaded thousands of times, underscoring the scientific robustness and relevance of the initiative. The continuity of data and time series was stressed as a key element for the long-term monitoring of cetaceans.

III. NATIONAL UPDATES

9. A roundtable was held, where participants were invited to share the latest updates regarding the development of ASI-II at their national level. The information is synthesized in the table below.

COUNTRY	INFORMATION UPDATE
Albania	Absent
Bulgaria	The representative from Bulgaria did not have the opportunity to participate in the meeting, but reaffirmed the commitment of the country in written by email (the amount of voluntary contribution for Bulgaria is 30 000 BGN per year, which is equivalent to 15 300 euros per year, so for 3 years it is 45 900 euros; it could be based only on contract and after the official launch of the project ASI-II)
Croatia	The representative from Croatia stated that the country was in the process of preparing a national aerial survey project. Field work is expected to begin in 2026.
Cyprus	The representative of stated that Cyprus is finalizing the procedures and preparations to conduct research expeditions during the second half of 2025 and throughout 2026.
Egypt	Absent
France	The representative from France stated that France fully supports ASI-II, emphasizing its importance within its obligations towards the MSFD. A common approach is crucial to achieve the stated objectives. However, financial issues remain a major concern. Regarding the feasibility of mobilizing European FEAMPA funds in addition to national participation it was stated that: There is a possibility of using funds outside EU. The results are rather encouraging in this regard. Regading transfer of funds to an international organisation, this seems feasible if the project is carried out by a French actor in collaboration with ACCOBAMS. It was stated that France also offers its support for the side event UNOC. It was noted that the results of ASI are particularly interesting and widely used in scientific work in France. The PELAGIS laboratory has been actively involved in several analyses and has valuable insights to share regarding the scientific and methodological approach of ASI-II.
Georgia	The representative of Georgia stated that at this stage, they do not have any updates regarding the development of ASI-II at the national level. However, they would like to highlight that Ilia State University has been conducting year-round surveys on marine mammals in Georgian waters since 2014, using passive acoustic monitoring

	to study cetacean distribution, seasonal activity, and behavior. The University is ready to actively contribute to the ASI-II initiative.
	In parallel, they would also like to note that under an environmental decision issued
	by the Ministry of Environmental Protection and Agriculture of Georgia, there are
	survey requirements in certain places for certain activities that may impact the
	marine environment. These requirements aim to ensure that potential effects on
	cetaceans are properly assessed and monitored. The research aims to avoid impacts
	on cetaceans while monitoring populations, assessing human-induced pressures,
	and identifying key periods such as migration and breeding seasons.
	Findings show that cetacean activity peaks in winter, spring, and early summer,
	underscoring the importance of these periods. Additionally, the studies have shown
	that dredging and other human activities present notable risks to marine mammal
	populations, reinforcing the need for appropriate mitigation measures.
Greece	The representative from Greece provided the Secretariat with a statement
	presenting national activities that they could benefit updated information towards
	the ASI project in Eastern Mediterranean region. The statement provided is <u>annexed</u>
	to this report.

Italy	The representative from Italy recalled recent discussions within the Scientific Committee and a national meeting held with the ACCOBAMS Secretariat in Italy,
	reaffirming the country's commitment to contributing to ASI-II. A large-scale marine
	survey, initially planned earlier, has now been rescheduled for 2026 to align with the
	ASI-II timeline. This survey, covering all Italian seas, will support Italy's obligations
	under the Marine Strategy Framework Directive (MSFD). Coordination with ASI-II is
	therefore essential. The representative also expressed its willingness to provide
	support beyond its national waters, including in surrounding sea areas, and is
	exploring opportunities for additional contributions.
Lebanon	The representative of Lebanon stated that the CNRS will facilitate the obtention of
	permits and authorization for the survey and that the scientific vessel CANA will be
	made available for the survey along with scientific researchers.
Libya	Absent
Malta	Regarding the surveying of cetaceans, the representative of Malta stated that Malta
	is in the process of developing the relevant procurement documentation for
	publishing probably later this year, with implementation of surveys related to
	cetaceans expected to be carried out in 2026. These are planned to include both
	vessel-based and aerial-based surveys within the Fishery Management Zone and
N400000	marine protected areas, and this in line with Malta's MSFD monitoring programme.
Monaco	The representative from Monaco reaffirmed its commitment to the ACCOBAMS Survey Initiative and pledges to mobilize both human and budgetary resources. The

Montenegro	The representative of Montenegro was absent.

Although there were attempts to postpone it to 2026, this was not possible, as the survey must be completed before May 2026. At this stage, no additional financial support has been secured for 2026. However, Spain expressed its willingness to assist the Secretariat in identifying potential private donors within the country. Additionally, the IEO (Spanish Institute of Oceanography) has shown openness to collaborate, particularly by contributing time and expertise for both the survey and subsequent data analysis.

Türkiye	The representative from Türkiye stated that, as previously mentioned in the LTMP Contact Group Meeting, are actively seeking both national and international funding opportunities. The budget required for national surveys within Turkish maritime jurisdiction areas must be requested annually. Additionally, marine mammals have been incorporated into the national integrated pollution monitoring program, which has been running since 2014 in the Turkish waters. Furthermore, the process of updating the marine mammal monitoring guide, developed as part of this program, is ongoing in alignment with the ACCOBAMS monitoring guidelines. They are also preparing a project specifically focused on cetaceans to secure international funding for their monitoring and conservation. It is expected that the outcomes of the project will contribute to ASI-II.
Ukraine	The representative from Ukraine informed about the progress of ongoing BlackCeTrends initiative for the stationary passive acoustic monitoring of cetaceans in the Black Sea which launched in 2020, at present covers research effort from five ACCOBAMS countries (Bulgaria, Georgia, Romania, Türkiye and Ukraine) and includes almost 20 stationary points of observation. Some important results were already obtained about the seasonality of porpoise occurrence throughout the coastal Blac Sea waters. Such an approach seems to be a promising part of multidisciplinary effort which can be scaled onto other ACCOBAMS subregions.

IV. CONCLUDING REMARKS AND NEXT STEPS

Regarding the Scientific Coordinator:

- 10. The urgency of appointing a Scientific Coordinator was strongly emphasized to update the ASI-II project proposal. A call for applications is expected to be launched soon.
- 11. The ASI-II scientific coordinator will utilize the existing survey design, updating it based on the current geopolitical context, lessons learned from ASI-I, and regional survey priorities.

Regarding National-level Involvement:

- 12. Regarding National-level involvement, Ms. Belmont reminded the group of the critical importance of receiving national-level feedback in the coming months to ensure accurate assessments of country-specific contexts.
- 13. She stated that further contact will be made in the upcoming weeks to complete information related to implementation aspects, including administrative matters, research permits, and security considerations.

UNOC3 side-event:

- 14. Ms. Salivas reiterated that UNOC3 represents a pivotal opportunity to launch ASI-II and to announce both financial and in-kind contributions to ASI-II.
- 15. She stated that responses to proposals submitted for the ASI-II side event at UNOC will be received during the week of April 14, 2025.
- 16. If the side event is not accepted in Blue-zone, the ACCOBAMS Secretariat will propose an off-site side event.
- 17. The Chair of ACCOBAMS, Ms. Marie Therese Gambin, thanked all Parties for their valuable information and ongoing support of the initiative, while encouraging continued efforts to seek additional resources.

Regarding the Hellenic Ministry of the Environment and Energy the following Statements to the ACCOBAMS Secretariat are included so that they could benefit updated information towards the ASI project in Eastern Mediterranean region:

JOINT MINISTERIAL DECISIONS and PROJECTS:

- a) Legislation of Measures for the operation of the Nationally Coordinated Network for monitoring and managing the stranding of marine wildlife species (cetaceans, seals, sea turtles and chondrichthyans). (Official Gazette 3376/B/19-5-2023 and 3926/B/20-6-2023). The coordinator of the first group of 14 organizations for the cetaceans is the Cetacean Rescue and Rehabilitation Research Center "ARION" and for the Mediterranean Monk Seals is the Hellenic Society for the Study of the Mediterranean Monk Seal- "MOm". There is also, "ARCHELON" that is coordinating the Sea turtles and "iSea" for the Chondrichtyans.
- b) Legislation for the Establishment and the license to operate the First Aid Centers and Stations for the Care of Wild Animals in Greece (Official Gazette 4744/B/8-9-2022).
- c) Under the auspices of the Ministry of Environment and NECCA the National Databank for Marine Species Population Monitoring and Strandings is designed and is planned to become operated until 2026. The databank will be a digitized and georeferenced tool available to the scientific community and related researchers.
- d) The implementation of the Action Plan for the mediterranean monk seal (*Monachus monachus*) (Official Gazette 05100/B/10-9-2024) and two cetaceans (*Tursiops truncatus* and *Phocoena phocoena*) (Official Gazette 73/B/17-1-2025) of the Ministry of Environment and Energy are now signed by Joint Ministerial Decisions and are into force.
- e) The LIFE MareNatura project (July 2023 June 2029) aims to mitigate the threats that affect nine (9) of the most threatened EU priority species of seabirds, marine turtles and marine mammals. These species are the Mediterranean Monk seal, the Loggerhead turtle, the Green turtle, the Sperm whale, the Harbour porpoise, the Cuvier's beaked whale, the Common dolphin, the Yelkouan shearwater and the Audouin's gull.

So far, most of the conservation efforts have targeted the breeding areas of these species and thus their offshore habitats (feeding grounds, congregation sites and migration corridors) remained to a large degree unexplored. The goal of the LIFE MareNatura Project is to significantly contribute to the conservation of these offshore habitats, through the identification of biodiversity hotspots in the Ionian, Southern Adriatic and Aegean Seas, strongholds of the target species populations, by employing a massive multidisciplinary survey effort through innovative technologies and methods. The project LIFE22-NAT-EL-101113792 (https://www.lifemarenatura.eu/en/) "Conservation of priority species of marine megafauna in Greece and Italy" – LIFE MareNatura is implemented with the contribution of 75% of the LIFE financial instrument of the European Commission and the co-financing of the A.G. Leventis Foundation. There are 14 partners that implement the project.

f) ENLARGEMENT OF THE MARINE PROTECTED AREAS' NETWORK OF GREECE TO MEET THE 30% TARGET.

Marine protected areas (MPAs) in Greece currently occupy an area of 22,796 km and cover 18.3% of the country's marine waters. According to par. 1 of Art. 174 of Law 5037/2023, MPAs have to expand to 30% of Greek territorial waters by 2030. To meet this target, Greece intends to establish two additional marine national parks (as per point a, par. 2 of Art. 19 of Law 1650/1986) covering OVER 32%.

IMPLEMENTING BODY/BENEFICIARY: NECCA

AREA: Mediterranean Sea (Ionian and Aegean Sea)

BUDGET: statutory measure + €10,707,187.54 from EU funds (LIFE program) &Green Fund.

- i. THE AEGEAN MARINE NATIONAL PARK with a total area of over 8,000 km (including the existing Natura 2000 areas of 545 km2). The park covers 6.61% of Greek territorial waters, (a net increase of Greek MPAs of over 6%). The core of the marine park is the small rocky islets, almost all of them being already designated as Important Bird and Biodiversity Areas (IBAs) and the surrounding marine environment. It builds on 13 existing Natura 2000 areas (GR3000011, GR4210011, GR4220007, GR4220030, GR4220023, GR4210009, GR4210022, GR4210007, GR4210032, GR4210023, GR4220022, GR4220036 and GR4210021) to expand the protection towards the sea. The main objective is to protect the wild birds that are in abundance in the area, i.e. sea birds such as *Phalacrocorax aristotelis desmarestii, Larus audouinii* and *Calonectris diomedea* as well as *Puffinus yelkouan* that use the sea as a feeding ground. In most of the islets there are also colonies of *Falco eleonorae*, whereas in Antimilos the Aquila fasciata is reproduced. The islets of the proposed park is also used by many migratory bird species for food and as a resting station during the spring and autumn migration. Furthermore, there is significant presence of seals *Monachus monachus* as well as dolphins such as *Delphinus delphis* and *Tursiops truncatus*, whereas, at deeper waters, there are cetaceans such as *Physeter macrocephalus, Stenella coeruleoalba and Ziphius cavirostris*.
- ii. **THE IONIAN MARINE NATIONAL PARK** (from north of Kefallonia to south of Antikythira) with a total area of over 14,000 km2 (including the existing Natura 2000 areas of 3,668.86 km2). The park covers over 11% of Greek territorial waters, the Ionian segment of the Hellenic trench being its core (a net increase of Greek MPAs of more than 8%) building on 13 existing Natura 2000 areas (GR222003, GR2220004, GR2220005, GR2220007, GR2210001, GR2210002, GR2210004, GR2550010, GR2330008, GR2540009, GR2540003, GR3000008 and GR3000019).
 - The park is established because the area is very important for marine mammals such as *Physeter macrocephalus, Ziphius cavirostris and Stenella coeruleoalba*. Furthermore, there is significant presence of seals *Monachus monachus* as well as dolphins *Grampus griseus, Delphinus delphis and Tursiops truncatus*. The area includes one of the most important areas for the nesting of *Caretta caretta*, areas with *Posidonia oceanic and Cystoseira sp.* as well as the natural habitat type of reefs. In deep waters, there are also coral formations and deep-sea corals are marine biogenic habitats of high conservation value of the country's territorial waters.
- 2. **ESTABLISH MONITORING AND EARLY WARNING SYSTEM FOR PASSING BY SHIPS TO IDENTIFY ON TIME LARGE MARINE MAMMALS** so that the ships that are in the Greek territorial waters slow down and avoid collision

with them in the area between Kythira, Cape Tainaro and Cape Maleas. A Memorandum of Understanding has been signed between the Ministry of Environment and Energy, the Ocean Care, Pelagos Cetological Research Institute and ITE-U of Crete are not developing the system **SaveWhales** a project with total cost of 3 million euros.

- 3. MARINE HABITAT MAPPING OF THE GREEK MARINE PROTECTED AREAS is an essential tool to gain a holistic representation of marine ecosystems and their distribution patterns and status, to design effective monitoring programmes and to deliver accurate and extensive on marine spatial planning, whilst to support policies on scaling up blue economy activities and simultaneously protecting and restoring marine protected areas. Marine habitat mapping in Greece involves all MPAs of the country that are included in the EU Natura 2000 network, 118 in total, covering 18.3% of the country's marine waters.
- 4. The Ministry of Environment and Energy (MEEN) has commissioned the preparation of 23 Special Studies Plans (SSPs) and Management Plans (MPs) for the 446 areas of the country's Natura 2000 network, divided into 11 groups of areas. The project envisages the demarcation and institutionalization of classified protection zones of Natura 2000 areas and corresponding conditions and restrictions on land uses and the exercise of activities, with multiple benefits both in terms of the protection of the natural environment and the development of the country. The SSPs will indicate the zones and permitted land uses within their boundaries, in relation to the protected species and habitats of each group of areas and in harmony with the anthropogenic activities of the wider area. The Management Plans will allow the establishment of rules for the exercise of permitted anthropogenic activities in the study areas. The project of preparing EPMs, PDs and Management Plans for areas of the Natura 2000 Network, which is being implemented for the first time in our country, is extremely important both for the protection of our natural environment and in relation to Greece's obligations towards in the European Union. For the implementation of the SSPs project, the Ministry of Natural Environment and Biodiversity (Directorate of Natural Environment and Biodiversity Management / Department of Protected Areas, as the managing agency) assigned the project to private researchers through relevant contracts, after an open international competition. 23 SSPs had been under open consultation and are expecting the Ministerial Decrees.

REPORT OF THE 5th MEETING OF THE LONG-TERM MONITORING PROGRAMME CONTACT GROUP ONLINE -1st OCTOBER 2025 | 10:00 -12:00 CET

The Fifth Meeting of the Long-Term Monitoring Programme (LTMP) Contact Group was held online on **1 October 2025**, **from 10:00 to 12:00 CET.** A total of 23 members from 16 countries participated in the meeting. The list of participants is <u>annexed</u> to this report.

The primary objective of this meeting was to provide an update on the progress made in the development of the **second edition of the ACCOBAMS Survey Initiative (ASI-II)** since the 4th Meeting of the LTMP Contact Group (April 2025) and to collect the most recent information on the ASI-II development at the national levels, gathering input from each participating country of the ACCOBAMS Long-term monitoring programme contact group.

I. OPENING AND PRESENTATION OF PROGRESS

- 1. Mrs. Maylis Salivas, ACCOBAMS Executive Secretary, opened the meeting by welcoming participants and presenting the agenda. She summarized the latest developments related to ASI-II since the last LTMP Contact Group meeting in April 2025. The full presentation is annexed to this report.
- 2. Mrs. Salivas revisited the background of ASI-II, highlighting the 8th Meeting of the Parties (MoP8) and the endorsement of Resolution 8.10, which provides the framework for the next basin-wide synoptic survey under ASI-II. She also recalled conclusions from previous LTMP Group and Bureau meetings to provide context for ongoing activities.
- 3. She reported on key developments within ASI-II, including the recruitment of key coordination personnel: Mrs. Julie Belmont for technical and administrative support and Mr. Panigada as ASI-II Scientific Coordinator. She introduced the new ASI-II logo and noted the successful UNOC3 ASI-II Launch Side Event held on 11 June 2025.
- 4. Follow-up actions with participating countries were outlined: coordination with Monaco and France to finalize MoUs and secure financial contributions (including a major financial contributions request made to the FEAMPA call in France), engagement with Italy on technical and scientific implementation, and meetings in Greece with the Directorate General and Prime Minister's Office to advance national participation. Further discussions took place with the U.S. Navy regarding their pledged financial support.
- 5. Coordination and fundraising efforts with private foundations were highlighted, particularly with the Prince Albert II of Monaco Foundation (FPA2), Audemars Watkins Foundation, and Thalassa Foundation (focused on communication and awareness activities for the later). Mrs. Salivas further noted ongoing collaborations with other partner organizations, including UNEP-MAP, SPA/RAC, and the SEMPA Project, as well as continued connection with Marine Conservation Research for the planning of boat survey operations.
- 6. Looking ahead, the next steps include organizing a technical workshop on ASI-II Survey Design in the MSFD subregions and beyond (scheduled in Milan, 5–7 November 2025) and developing a tentative retro-planning for ASI-II activities covering 2026–2028. Additionally, two side events are being prepared in conjunction with MoP9 and the Barcelona COP to further promote the programme and its outcomes.

- 7. In presenting the updated provisional budget, Mrs. Salivas noted that approximately €533,000 in additional funding is still required. She also stressed the risks associated with delays in securing commitments from key funding sources—particularly the French FEAMPA support—and the potential impact on operational activities, such as mobilizing boats and contracting aircraft operators in a timely manner.
- 8. She emphasized the need for increased financial contributions to ensure full coverage of all participating countries, noting that in-kind support alone will not be sufficient and will not allow the extension of ASI II campaigns as was possible with ASI I, stressing the importance of maintaining the synoptic objective of the initiative.
- 9. Dr. Simone Panigada, ASI-II Scientific Coordinator, emphasized the importance of the collaborative small team supporting ASI-II scientific activities, including coordination with the SCAN survey coordinator for planning data collection and analysis. He confirmed the commitment to a basin-wide synoptic survey using both aerial and boat surveys, building on ASI-I's successful outcomes, but also noting that the geopolitical situation is more challenging than during ASI I.
- 10. Dr. Panigada noted that ASI-II differs from ASI-I as several monitoring activities will be conducted directly by participating countries, making early communication essential for a shared survey design and standardized protocols. He welcomed the commitment of many countries and offered to discuss potential overlaps and synergies to achieve consistent outcomes.

II. NATIONAL UPDATES

11.A roundtable was held, where participants were invited to share the latest updates regarding the development of ASI-II at their national level. The information provided by those present in the meeting is synthesized in the table below.

She also commended Dr. Panigada and Mrs. Julie Belmont for their role and reaffirmed her full availability.

13.Mrs. Salivas and Dr. Panigada closed the meeting by emphasizing the importance of full support from all partners. They reminded participants that ASI II is a collective effort across the entire ACCOBAMS area, highlighting the value of mutual support and expressed gratitude for the collaboration and dedication of all participants.


